# **City of Peosta Government 101**

# Series of articles to educate and inform the citizen and businesses of Peosta

#### What is Public Right of Ways and Easements?

**Public Right of Way**. The public right-of-way (ROW) generally are considered public spaces or public access areas that are necessary to provide infrastructure, such as public streets, parking area, sidewalks, trails, vegetation cover and strips of land between the sidewalk and roadway. The width of the ROW can vary significantly based on the width of the street needed for transportation purposes. Generally, the ROW on a common city street is 50 to 60 feet wide. For the sake of conversation, the City of Peosta, by ordinance, requires all new streets to be 60 feet wide.

Typically, the maintenance of the area between the sidewalk and the street is the responsibility of the abutting property owner as designated by the city ordinance. Also, the city has the right to determine what takes place in the ROW through its code of ordinances and related policies.

**Easement.** An easement provides a means for access within the ROW's. this allows for vehicle and pedestrian travel. In addition to transportation access, an easement allows utilities to the strip of land between sidewalk infrastructure and the street/curb. Cities manage this area and allow permission through easements for utilities such as water, sewer, storm sewer, gas, electrical and telecommunications to access the ROW to maintain existing utilities, make repairs and allow for new utility installation.

You may ask, "What are the City's requirements for ROW management?"

The Code of Iowa does not have many specific requirements on how cities regulate its ROW. In addition, Iowa is a home rule state which grants cities and their elected officials the ability to exercise authority in the best interests of their citizens. Section 364.12 of the state code establishes responsibilities for public access and states that cities are responsible for keeping all public grounds "in repair, and fee of nuisance." This includes streets, sidewalks, alleys, bridges, culverts, overpasses, underpasses, grade crossing separations and approaches, public ways, squares, and common areas. That section of the state code also permits cities, by ordinance, to make abutting property owners for maintaining the portion of the ROW between the sidewalk and street. It is a good idea for cities and property owners to understand who is responsible for maintaining the various elements of ROW. Because of this, city ordinances define the right to occupy, and have permits to perform work and have in place, the general regulations of the ROW.

What are some of the most common regulations? Some of the most common regulations defined in our ordinance include excavation, drainage, placement of signs, maintenance (including grass) and the maintenance of sidewalks, which include the removal of snow and limiting debris (grass) into the ROW. **When in doubt, call the City.** 

Our City ordinance defines what time period is considered reasonable for responsibilities related to mowing and clearing snow/ice accumulations, as well as how failure to perform such responsibilities will be handled. Ordinances may permit the city to perform, or hire out,

the necessary work and assess a reasonable cost to the property owner in the same manner as a property tax.

The state code also addresses sidewalk maintenance and responsibilities, allowing cities to create ordinances requiring abutting property owners to maintain and repair sidewalks. State code also allows cities to require installation of sidewalks with proper notice. There are many types of easements, and not to bore anyone, but here is a list of the different types.

Utility easements: for public utilities to install and maintain lines, pipes, wires, etc.

**Private easements:** for private parties to use a portion of another's property, such as a driveway or a path.

**Easements by necessity:** for landlocked owners to access a public road through a neighboring property.

**Prescriptive easements:** for someone who has used another's property openly, continuously, and without permission for a certain period of time.

**Easement appurtenant:** for a property owner to use an adjacent property that benefits their own property, such as a shared well or a fence.

How can an easement be removed? The time it takes to remove an easement can vary depending on the circumstances and the method used. The duration of each method can also vary on factors such as legal requirements, negotiations with other parties involved, and possibly court proceedings.

The important take away from this article is to contact us before you think about doing anything in the ROW.

# **Police Department**

I know it's a four-letter word we never want to hear....SNOW! It's coming soon and we need to prepare for the possibility for snow. As a reminder, don't push snow from your driveway on to the streets, please remove snow from sidewalks and driveways withing 24-hours of snowfall, and keep vehicles off the streets during snow emergency declarations.

3-12-2 SNOW EMERGENCY DECLARATION. A snow emergency is defined as any amount of snow. Snow combined with ice, rain and/or wind may also constitute a snow emergency. The Mayor and/or his/her designee may declare a snow emergency. A snow emergency may be declared in advance of an anticipated storm, during a storm or after a storm.

A snow emergency will normally not last more than 24 hours past the end of the last snowfall; but may be extended or shortened when conditions warrant. The public will be informed of a snow emergency through mass media outlets as deemed necessary by the Mayor.

3-12-4 DRIVEWAYS AND SNOW FROM PRIVATE PROPERTY. City snowplows will not clear private driveways. The snow placed in driveways by the city plows is an unavoidable consequence of removing snow from the streets and it is the responsibility of the property owner

to remove. Snow from private driveways, private parking lots and sidewalks may not be placed

on city streets.

3-12-5 REMOVAL OF SNOW AND ICE ACCUMULATIONS ON SIDEWALKS. It is the responsibility of the abutting property owners to remove snow and ice accumulations from sidewalks. If a property owner does not remove snow and ice accumulations within twenty-four

(24) hours after deposit of accumulation, the City will attempt to notify the resident and give an

additional twenty-four (24) hours to clear or the City may do so and assess the costs against the

property owner for collection in the same manner as a property tax, as provided in Section 6-8-3

of the Peosta Code.

3-12-6 VEHICLE PARKING DURING A SNOW EMERGENCY. No person shall park, abandon or leave unattended any vehicle on any public street, alley or City-owned off-street parking area during a snow emergency proclaimed by the Mayor unless the snow has been removed or plowed from said street, alley or parking area and the snow has ceased to fall. Vehicles parked on the street during a snow emergency are subject to tow without notice to the

owners at the owner's expense. A snow emergency parking ban shall continue from its proclamation through the duration of the snow or ice storm and the twenty-four (24) hour period

after cessation of the storm except as above provided upon streets that have been fully opened.

The ban shall be of uniform application and the Police Chief is directed to publicize the requirements, using all available news media, in early November each year. The emergency may

be extended or shortened when conditions warrant.

3-12-7 PUSHING SNOW INTO STREETS. A person or entity shall not push, plow or place any snow into, onto or across any public street. Penalty per violation in twelve (12) month period:

First offense Warning Second offense Warning

Third offense \$25.00 civil penalty plus court costs Fourth offense \$50.00 civil penalty plus court costs Fifth offense \$100.00 civil penalty plus court costs
